- M. Public Comment Sheriff Marty Mechaley stated he will be negotiating with the City of Custer on next year's law enforcement contract and would like to have a commissioner present at that meeting. Commissioner Sorenson volunteered to attend the meeting. The commission was informed of flooding that occurred in the basement of the courthouse early this morning. There was 4" of water in the basement and the maintenance department is handling this issue. Director of Equalization, Patty Caster, stated she had a request from a taxpayer on whether or not there is a form to fill out to request an area to be declared a blighted area and thus qualify for the discretionary. It was determined there is not currently a form and the commission would need to establish guidelines and pass a resolution.
