## **Custer County Commission Meeting (Wednesday, August 8, 2018)**

## D. Highway

- Motion by Lintz and seconded by Sorenson to approve Brosz Engineering agreements for design on Spring Creek Cutoff Road SN 17-547-020, Bison Lane SN 17-540-147 and Fairburn Road SN 17-535-143. Motion carried, unanimous.
- 2. Motion by Lintz and seconded by Bies to authorize Gary Woodford, Highway Superintendent, to advertise and purchase two trucks from Eddie's Truck Sales. The trucks were surplus from Hughes County, South Dakota. Motion carried.
- 3. Motion by Lintz and seconded by Sorenson to authorize the county shop to maintain the 2.1 miles of French Fork Road. Motion carried, Commissioner Bies abstained.

# E. Veteran Memorial

There was no person in attendance to the commission meeting to address the request for assistance with gravel needs to complete the veteran memorial.

### F. Planning

1. Motion by Hartman and seconded by Bies to approve the Wireless Tower Communication Tower Modification from T Mobile at the Crazy Horse Tower located in the NW4SW4 of Section 34, T2S, R4E, Custer County, South Dakota. Motion carried, unanimous.

## G. Safety Officer

1. Kim Kerkvliet, Safety Officer, reported that she had met with States Attorney Tracy Kelley, and the drug and alcohol policy would be the same in the Custer County Safety Manual as it is in the Custer County Employee Handbook. Kerkvliet will forward the completed Custer County Safety Manual to all the commissioners when it is finished. Kerkvliet also reported that she had accepted a bid from Western States Fire Protection for wall mounted fire extinguishers that will be installed at a later date. Kerkvliet will also have a training session for county employees on proper use of the fire extinguishers as well as an emergency evacuation plan.

# H. Airport

1. Kent Penney from Kadrmas Lee & Jackson Inc. presented to the commission along with Rex Harris, Planning Director, to discuss the county's application for federal assistance in the widening design phase of the airport runway project. The total cost of the design phase of the project is \$360,000, with the county share of \$18,000. Motion by Sorenson and seconded by

Hartman to approve and authorize the chairman to sign the Application for Federal Assistance. Motion carried, unanimous.

#### I. Sheriff

1. Motion by Sorenson and seconded by Hartman to approve and authorize the chairman to sign the 2019 Law Enforcement Agreement with the City of Custer. Motion carried, unanimous.

# J. Fire Advisory Board

1. Matthew Spring, Custer Fire Advisory Board Chairman, reported that the Fire Advisory Board had met on the 2<sup>nd</sup> of August and discussed the needs of the fire departments for the coming year. Custer Highlands Fire Department is requesting an additional \$13,550 to their current budget of \$23,000. The board would also like to request an additional amount of \$200,000 for bunker gear and air pack sets, \$50,000 for radios and \$75,000 for a Type 3 Unit for the Pringle Fire Department. The commission commented that if at the end of the year the county had a surplus in funds they would consider allocating some of that money to the fire departments.

# K. SDSU Extension Service

1. Angie Keierleber gave the commission an update on the extension and conservation offices. The Custer County Fair will be held on August 9<sup>th</sup> through the 12<sup>th</sup> and she has judges lined up for the 4-H entries. Keierleber requested that the commission consider allowing Sherry Weber to continue working in the Extension Office one day a week through the months of September and October of 2018. Motion by Sorenson and seconded by Bies to approve Sherry Weber, nurse secretary, to work one day a week in the Extension Office during the months of September and October to continue training on 4-H activities. Keierleber also gave an update on the Conservation Office.

### L. Maintenance

1. Motion by Hartman and seconded by Sorenson to approve the payment of \$5,370 to CR Concrete & Masonry for concrete and stone replacement on the flowerbox located on the east side of the courthouse building. Motion carried, unanimous.

# M. Equalization

- 1. Patty Caster, Director of Equalization, reviewed the current discretionary formula for new commercial structures and additions. The new formula is 0% tax on the structure or addition for five years. Commissioner Hartman was advised to abstain from the discussion due to a conflict of interest. It was the consensus of the commission to invite all town boards to the next commission meeting to get their input on the discretionary formula.
- 2. Caster informed the commission that the South Dakota Department of Revenue will be holding an agricultural workshop in Sturgis, SD, on the 20<sup>th</sup> of August at 10:00 a.m. Caster and Appraiser Amanda Pierce will be attending the workshop and the commission is invited to attend as well.

# N. Auditor

- 1. The commission acknowledged the completion of six month probation for Jeremy Uphoff and Christina Bohnet, Deputy Auditor II's.
- 2. Motion by Lintz and seconded by Bies to approve the revised Order for Organization and Incorporation of the Lakota Lake Encampment Road District located in Custer County, South

- Dakota, which indicates the road district overlaps into Pennington County. Motion carried, unanimous.
- 3. Auditor, Terri Cornelison, reviewed the proposed 2019 department budgets and shared with the commission the breakdown of tax dollars to each taxing entity. The commission will need to have the 2019 provisional budget completed at the next commission meeting on August 22<sup>nd</sup>.
- 4. Motion by Hartman and seconded by Bies to approve the 3<sup>rd</sup> Quarterly Activity Report for Emergency Management. Motion carried, unanimous.
- O. Public Comment Mark Stites, Custer County Airport Manager, reported to the commission that there are four county owned airports in the State of South Dakota. Gary Enright with the Courthouse Museum reported to the commission that the museum has an opportunity to acquire an original cabin located at a former stage coach stop in Custer County and will be bringing that information to the commission at a future meeting.

- 1. Mail call Thank you note from Keith & Judy Troili for mag watering on Box Canyon Road; Notice from SD DOT Public Meeting for the Black Hills Context Sensitive Corridors Study.
- 2. Meeting Schedule The Custer County Fair will be held August 9<sup>th</sup> through the 12<sup>th</sup> at the Custer County Fairgrounds in Hermosa. Commissioner Sorenson reminded everyone that Black Hills Coop will sponsor the dinner on Thursday night, August 9<sup>th</sup>. The county will participate in the parade on Sunday, August 12<sup>th</sup>.
- 3. Meeting Reports Commission Lampert reminded everyone that there is a new art gallery display in the court house and encouraged everyone to take time to view the new art displayed.

### Q. Executive Session

- 1. Motion by Lintz and seconded by Sorenson to go into Executive Session pursuant SDCL 1-25-2(1), SDCL 1-25-2(3), and SDCL 28-13-42. Executive Session began at 10:12 a.m. to discuss personnel, consult with legal counsel and one indigent request and concluded at 11:14 a.m.
- 2. Motion by Bies and seconded by Hartman to authorize States Attorney Tracy Kelley to advertise to hire an additional part-time deputy states' attorney. Motion carried, unanimous.
- 3. Motion by Lintz and seconded by Sorenson to authorize States Attorney Tracy Kelley to add Custer County to the PILT Class Action Lawsuit to recover lost payment. Motion carried, unanimous.
- 4. Motion by Hartman and seconded by Lintz to approve the indigent request. Motion carried, unanimous.

Motion by Lintz and seconded by Hartman to adjourn the meeting at 11:21 a.m. The next meeting will be at 8 a.m. August 22, 2018 in the Commissioner's Room in the Custer County Courthouse.
