E. Ordinance #2

1. Marvin and Deborah Glemming, along with their attorney, Jason Smiley, appeared before the commission to request the county enforce the provisions of Custer County Ordinance #2 as it relates to CBJJ Subdivision. The Glemmings complaint arises out of the use of certain lots within CBJJ Subdivision that are being used to graze cattle. Glemming's attorney stated that the subdivision covenants do not allow the property to be used for such purposes and informed the commission that they had filed a lawsuit seeking to enforce the covenants. Smiley acknowledged that the covenants have no bearing on the County but he further argued that Ordinance #2 does not allow lots within a residential subdivision to be used for such purposes. The commission advised that they will discuss the issues raised with the Custer County State's Attorney, Tracy Kelley.

F. Airport

- 1. Motion by Lintz and seconded by Hartman to approve and authorize the chairman to sign a new hangar lease for the Blendable Foundation. Motion carried, unanimous.
- 2. Motion by Hartman and seconded by Sorenson to approve and authorize the chairman to sign the Airport Grant Pre Application Checklist. Motion carried, unanimous.
- 3. Motion by Lintz and seconded by Sorenson to table the airport hangar for sale discussion until the next commission meeting on November 7th, to allow Tracy Kelley, Custer County State's Attorney, time to review.

G. Sheriff

- 1. Sheriff Marty Mechaley reviewed the "Satellite Tracking of People" system being implemented by the Sheriff's Office. The system allows offenders to wear an ankle tracking device as opposed to being incarcerated. The offender is then able to go to work each day and the tracking device allows the Sheriff's Office to keep track of where the offender is. The tracking device is paid for by the offender and is a huge cost savings as opposed to paying for the offender to be incarcerated.
- 2. Motion by Hartman and seconded by Lintz to authorize an Automatic Supplement of \$14,000 from 24/7 Staffing Grant Account #248-334.00 to the 24/7 Sobriety Program Salaries and Wages Account #248-4-212-411.00. Motion carried, unanimous.
- 3. Motion by Sorenson and seconded by Hartman to approve the new hire of Mindy Pilcher as Dispatcher starting October 25, 2018, at a wage of \$15.62 per hour. Motion carried, unanimous.

H. Treasurer

1. Motion by Hartman and seconded by Lintz to approve the new hire of Jill McNulty as Deputy Treasurer starting October 16, 2018, at a wage of \$13.23 per hour. Motion carried, unanimous.

I. Library

- 1. Motion by Lintz and seconded by Sorenson to approve the new hire of Thea Teasley as Library Assistant starting October 15, 2018, at a wage of \$12.60 per hour. Motion carried, unanimous.
- 2. Motion by Sorenson and seconded by Lintz to approve the surplus of a 29" x 25" x8" child's desk to be disposed. Motion carried, unanimous.

3. Doris Ann Mertz, Library Director, gave a presentation on the proposed Library addition. Mertz is asking for a 24' x 58' addition to the northwestern corner of the current library building. The addition allows for more work room, an office, three study rooms, a large conference room that can be divided into two sections if needed, a book sale area and storage. Motion by Hartman and seconded by Lintz to authorize the project to be put out to bid and to approve \$150,000 from the building fund to be used for the project. Motion carried, unanimous.

J. Extension Office

Angie Keierleber, Extension and Conservation Office Manager, gave an update to the commission. The South Dakota State University is currently reviewing applications for the 4H Advisor position. Keierleber noted the Conservation Office has applied for two grants. One grant is for thinning and the other grant is to provide technical and cost-share assistance for private landowners along French Creek to restore native riparian trees and shrubs for the purpose of improving bank stability, water quality and wildlife habitat on French Creek.

K. Auditor

- 1. Motion by Hartman and seconded by Sorenson to approve Health Plans #3 (\$2,000 deductible) and #5 (HSA) for all county employees for 2019. Motion carried, unanimous.
- 2. Discussion was held on the excess surplus general fund dollars. Motion by Lintz and seconded by Bies to assign from the unassigned reserved fund the following:

 - 3. Motion by Bies and seconded by Sorenson to declare Monday, December 24, 2018 and Monday, December 31, 2018 as Holidays and to authorize Holiday pay for all county employees, which follows the state administrative leave that was granted by Governor Dauggard. Motion carried, unanimous.

- Gary Woodford, Highway Superintendent, presented information to the commission concerning the current county road system and the different levels of maintenance for roads. Tracy Kelley, State's Attorney, will work with Woodford to draft a new resolution to identify county roads that will be designated as "no maintenance" roads for the commissions consideration at the next meeting.
- **M.** Public Comment Patty Caster, Director of Equalization, shared a complaint from a taxpayer concerning trash disposal and the cost to take trash to the transfer site for Sander Sanitation.
