G. Highway

 Motion by Sorenson and seconded by Hartman to approve Resolution 2019-04. Motion carried, unanimous.

Resolution 2019-04 County Roads Weights and Speed Enforcement

WHEREAS, the County Roads deteriorate when the frost goes out, and

WHEREAS, all Custer County Roads will have 6-Ton per axle load limit in the spring of 2019. These Roads will be designated with a blue county shield OR a green rectangular sign marked with the county road number and the words Custer County and,

WHEREAS, The County Road design does not permit safe travel at the 65 MPH as adopted by the State and Custer County Roads will remain at 55 MPH unless otherwise designated by the posting of a lower speed limit. (SDCL 32-25-9.1)

NOW, THEREFORE, BE IT RESOLVED: WHEREAS, Custer County roads will have a 6-ton per axle load limit in the spring and a 55 MPH speed limit or lower as posted. That the South Dakota Highway Patrol be and hereby is authorized and requested to enforce weight limitations and speed limits on Custer County roads.

BE IT FURTHER RESOLVED, the penalty for the violation of the load restrictions shall be set forth in SDCL 32-22-55.

• Gary Woodford, Highway Superintendent, read the proposed Resolution 2018-13 No Maintenance Highways Within Custer County. The Resolution identifies the following as no maintenance roads: CS 24 or French Fork Cutoff for a distance of 3.62 miles from its intersection with CS 18 to its intersection with CS27; That portion of Battle Creek Road extending North West from the intersection of Battle Creek Road and Bender Road, excluding creek crossings; and The platted county road extending 1.9 miles from road 656 to the Fall River County line. Woodford reported he had placed a traffic counter on the French Fork Cutoff road and the average traffic was 30 vehicles per day. Motion by Hindle and seconded by Hartman to not pass Resolution 2018-13. Motion carried, Aye – Hartman, Hindle and Linde, Nay – Sorenson. Motion by Hartman and seconded by Hindle to untable the action on French Fork Road from the September 12, 2018 commission meeting that put the work on hold and to allow the Highway Department to proceed with the maintenance of the road that was approved at the August 8, 2018 commission meeting. Motion carried, Aye – Hartman, Linde and Hindle, Nay – Sorenson.

H. Planning Department

Kim Kerkvliet, Planning Director, reviewed the yearly report compared to prior year:

- 2017 37 plats, 161 building permits, 77 waste water permits, 3 wireless communication tower permits, 2 sign permits and 1 grading permit.
- 2018 32 plats, 160 building permits, 73 waste water permits, 6 wireless communication tower permits, 1 sign permit and a refund of \$902.40
- Total fees were up in 2018 \$92,813 compared to \$75,422.39 in 2017.

I. Airport

- Mark Stites presented the 2018 Custer County Airport report to the commission. Highlights from the report included:
 - Increase in medical transport flights
 - Forest Service helicopter response team spends summer fighting Colorado fires
 - New 8,000 gallon Jet Fuel tank installed
 - Over 100 cars rented to visitors
 - Unexpected repairs to tractor used for mowing/plowing
 - Tourist traffic increased
 - RPZ project winds down
 - FAA/State/County begin 2 year project updating Airport Master Plan
 - After 5 years two abandoned aircraft still parked on airport ramp
- Stites gave his support to a local company that offered car rentals at the airport. He reported that the company was willing to pay Custer County \$10 for every car rental in 2019.
- The airport will continue with phase 2 of the Jet-A Fuel Dispenser project with an estimated cost of \$45,000, which is included in the 2019 airport budget.
- Verl Scheibe has a hangar for sale and the commission instructed Stites to check and see if the hangar is purchased by the county would the cost would qualify for reimbursement through FAA. Motion by Hartman and seconded by Sorenson to authorize Stites and Commissioner

Hindle to negotiate a price for the hangar and bring to the next commission meeting. Motion carried, unanimous.

J. Emergency Management

- Motion by Sorenson and seconded by Linde to approve and authorize the chairman to sign the Personnel Action Form for the South Dakota Office of Emergency Management. Motion carried, unanimous.
- Motion by Hartman and seconded by Sorenson to approve and authorize the chairman to sign the 2019 State and Local Agreement. Motion carried, unanimous.

K. Veteran Service Office

• Jana Virtue, Veteran Service Officer, presented a 2018 4th Quarter report to the commission. Virtue attended meetings for the Veteran Memorial Park, a mini conference at the new CARE facility in Rapid City and assisted many veterans during the months of October, November and December of 2018.

L. Custer County American Legion

• Motion by Hartman and seconded by Sorenson to approve Resolution 2019-05 Resolution to Establish 2019 as the American Legion Centennial Year. Motion carried, unanimous.

• Jim Olson, representative for Custer County, presented an update on the Custer Community Action Team. During the month of December 2018, 123 families received commodities, had a total of 250.50 hours of volunteer time, operated the 'thrift store', and assisted eligible families with furnace installations, weatherization of homes and fuel assistance.

O. Civil Air Patrol

- Motion by Sorenson and seconded by Linde to approve a five year continuation of the lease between Custer County and the Civil Air Patrol effective March 31, 2019 until March 31, 2024. Motion carried, unanimous.
- Public Comment Travis Hartshorn asked for clarification on the assignment of \$15,000 to the Weed & Pest budget at the December 27, 2018 commission meeting. Linde asked Doris Ann Mertz how the new Library addition is going and Mertz reported she would be attending a meeting later that day with the Library Board and the project is in the initial stage. Linda Kramer with the Town of Hermosa reported that she and two other residents from Hermosa will be attending the commissioning of the USS SD.

Q. Commission

- Mail call Letter was received from South Dakota Retirement System notifying the commission of a commissioner representative opening on their board; Letter of retirement from Deputy Sheriff Heath Lowery. The commission acknowledged the letter of retirement.
- Meeting Schedule Lintz will attend a Fire Advisory Board on Thursday, January 10.
- Meeting Reports Lintz attended a Fair Board meeting on January 9, 2019 and the board is continuing with their improvement plan; there will be three commissioners in attendance at the Custer Area Economic Development meeting tonight at the Beggin Burro.

R. Executive Session

- Motion by Sorenson and seconded by Hindle to go into Executive Session pursuant to SDCL 1-25-2(1), SDCL 1-25-2(4), SDCL 1-25-2 and SDCL 28-13-42. Executive Session started at 9:49 a.m. to discuss personnel, contract negotiations and an indigent request and concluded at 11:00 a.m.
- Motion by Sorenson and seconded by Hartman to appoint Jana Virtue as Veteran Service Officer for a 4 year term effective January 9, 2019. Motion carried, unanimous.
- Motion by Sorenson and seconded by Linde to approve the indigent burial cost request in the amount of \$1,725. Motion carried, unanimous.

- Motion by Hartman and seconded by Hindle to approve the Consulting Contract and Airport Manager Contract that will be drawn up by States Attorney Tracy Kelley. Motion carried, unanimous.
- Motion by Hindle and seconded by Sorenson to approve and additional four hours per week of flex time for Veteran Service Officer, Jana Virtue, on an as needed basis to accommodate visits to veterans outside of the office and the Veteran Service Office to remain open Monday, Tuesday and Wednesday. Motion carried, unanimous.
