## E. Highway

## F. Custer Teammates

1. Bob Parsons with Teammates presented to the commission. Teammates is a school-based, one to one, relationship based mentoring program. Teammates is primarily funded through private donations and grants. The start up fee for the first year of the program per school district is \$15,000, with an annual cost of \$7,000. The Custer School District is in the process of implementing the program in Custer and Hermosa and asked if Custer County would be willing to make a onetime donation to help support the progam. Motion by Hartman and seconded by Sorenson to assign \$15,000 to Custer Teammates from the unassigned reserve fund Account #101-277.00. Motion carried, unanimous.
