J. Western SD Community Action & Custer Community Action Team

 Jim Olson, representative from the Western SD Community Action & Custer Community Action Team, presented his quarterly report to the commission. The team provided a total of 28,204 pounds of food in 2018. Family units served in January were 112, February was 127 and March was 116. Other programs offered include school supplies, personal care products, garden seed and plants and a youth recreation training.

K. Insurance at the Custer County Fairgrounds

- 1. Paul DeHaan from First Western Insurance presented to the commission on the current property and liability insurance for the Custer County Fairgrounds. The county currently carries a \$1,000,000 general liability policy with a \$5,000 medical expense. Betty Dikoff with the Custer County Fair Board reported the Fair Board carries their own insurance and requires any entity running an event on the fairgrounds to have their own insurance. DeHaan reported that the county insurance only covers events held at the fairgrounds that are run by the county and does not cover events run by other entities at the fairgrounds.
- L. Public Comment Brendon Hendrickson, Custer County Airport Manager, reported that he had attended an aviation convention in Watertown, SD, the prior week and learned the FAA does not have any funding available to assist in the purchase of a hangar that was offered for sale to the county. The two non working airplanes located on the airport property have been moved into a hangar for storage.
