# E. Highway

1. Bob Schmitt appeared before the board with concerns on the road condition in the Morkens Bear Springs Subdivision. The Forest Service has an easement that goes through their property. Schmitt claimed the road is not being maintained properly. Tracy Anderson, Forest Service Hell Canyon District Ranger, was also in attendance and stated the road in question is an open road to the National public. Anderson advised Schmitt that the Forest Service would be willing to talk with the concerned landowners to see if a solution could be reached.

- Motion by Hartman and seconded by Hindle to approve and authorize the chairman to sign the Apportionment of Highway Infrastructure Program Funds pursuant to the Department of Transportation Appropriations Act, 2019 Fact Sheet. Custer County will receive \$37,150.66 to rehabilitate bridges identified as Str. No. 17-379-260 and Str. No. 17-535-143. Motion carried, unanimous.
- 3. Linda Fellows and other land owners appeared before the board to express their concerns on Little Italy Road. The county has repaired a portion of the road that is not in a road district and now there are weight limits on the road. These limits do not allow the landowners in the Limbo Road District to haul materials in to fix the issues with their road. The Highway Department will work with the landowners to try to come up with a solution to help them get their road repaired.
