M. 1881 Courthouse Museum

N. Proposed Crazy Horse Scenic Byway

1. Steve Grabill with Kadrmas Lee & Jackson appeared before the board as a follow-up from the commission meeting on November 6, 2019. The Oglala Sioux Tribe is proposing a scenic byway route in Custer County that would be along existing SD Hwy 40, SD Hwy 36, US Hwy 16A until it enters Pennington County and then back in Custer County on US Hwy 16/385. The tribe is requesting a letter of support from Custer County. Motion by Hindle and seconded by Linde to table until the December 4, 2019 Commission Meeting; vote, all aye; motion carried.

O. Custer County Volunteer Fire Departments

- 1. The Custer County Fire Advisory Board made a motion at the November 14th Fire Advisory Board meeting to allocate the \$200,000 as requested by the Custer County Commission at the October 23, 2019 Commission meeting to help departments meet current needs. Motion by Sorenson and seconded by Hartman to approve the allocation with the recommendation for fire departments to provide financial statements before any additional funding from the commission; vote, all aye; motion carried.
- Discussion was held on the costs of new radios that will be required by Fire Departments to obtain in order to meet the new standards that will go into effect in 2022. Mike Carter, Emergency Management, will work with the Fire Chiefs to determine how many radios are needed and the cost to purchase.
