D. Conflict of Interest Declarations – there were no conflicts of interest declared.

E. Highway

 Gary Woodford, Highway Superintendent, presented to the board a proposal from Butler Machinery to purchase a new 140-13A Motor Grader for \$218,800. The price includes the trade allowance of \$85,000 for a 140M AWD Caterpillar that the county currently owns. Motion by Hartman and seconded by Sorenson to table the proposal until after Executive Session; vote, all aye; motion carried.

F. Weed & Pest

- 1. Caley Buckert, Weed & Pest Supervisor, updated the commission on the work done this past summer. There were 110 letters sent to land owners regarding weed control and Buckert visited 15 landowners to assist with weed control. The chemical reimbursement program will be issuing checks to land owners for chemical reimbursement for a total of \$19,577.09. Buckert stated that with available funds she was able to reimburse landowners 75% of cost. Caley and her two seasonal sprayers were able to spray the county roads once and completed an agreement with the Forest Service.
- 2. Buckert reminded the commission that the Part-time Weed & Pest Coordinator position currently being held by Gary Woodford may need to be address in the coming year. The weed and pest and conservation boards may assist with direction for this role.

G. Custer County Standard Fee and Permit Policy

1. Motion by Sorenson and seconded by Hindle to table the Custer County Standard Fee and Permit Policy to the first commission meeting in January of 2020; vote, all aye; motion carried.

H. Proposed Crazy Horse Scenic Byway

1. Tonya Huber with Kadrmas Lee & Jackson Engineering presented to the commission on the proposed scenic byway application from the Oglala Sioux Tribe. The proposed route would be along existing SD Hwy 40, SD Hwy 36, and US Hwy 16A until it enters Pennington County and then back in Custer County on US Hwy 16/385 where it ends at Crazy Horse Memorial. Several residents of the county attended to express their opposition to the application because of potential impacts to their property that have not been addressed in the application. Also, potential costs to the County were not addressed. Motion by Sorenson and seconded by

Hindle for the county to not support the Oglala Sioux Tribe's application of the Proposed Crazy Horse Scenic Byway; vote, all aye; motion carried.

I. South Dakota Department of Health

1. Motion by Hartman and seconded by Sorenson to approve and authorize the chairman to sign the State of South Dakota Consultant Contract for Provision of Community Health Services between Custer County and South Dakota Department of Health; vote, all aye; motion carried.

J. Auditor

- 1. The commission acknowledged the resignation of Bobbie Johnson, Deputy Auditor, effective December 2, 2019.
- 2. Motion by Sorenson and seconded by Linde to adopt, approve and ratify the South Dakota School District Benefits Fund Participation Agreement as presented; vote, all aye; motion carried.
- 3. Motion by Sorenson and seconded by Linde to approve the South Dakota Public Assurance Alliance 2020 Anniversary Rating Supplement with recommendations of eight highway vehicles to be removed from full coverage insurance and be insured for liability only and removal of a 1982 Kenworth W900 truck from the county's insurance; vote, all aye; motion carried.
- 4. Motion by Hindle and seconded by Linde to approve the new hire of Karen Hicks as Deputy Auditor starting December 16, 2019, at a wage of \$13.23 per hour; vote, all aye; motion carried.

K. Application for Isolated Tract Easement

1. Motion by Sorenson and seconded by Linde to table the Application for Isolated Tract Easement from Richard and Barbara Drew until the second commission meeting in January of 2020; vote, all aye; motion carried.

- his desire to work long-term for the county. The commission took public comment from individuals in attendance to support keeping Hendrickson as the Airport Manager.

Motion by Hartman to rescind the motion passed at the October 23, 2019 commission meeting "that per the terms of the Custer County Airport Management Contract, the County will issue a notice of the county's intent not to renew the contract for a renewal period of 5 years and to revise the duties of the position and re-advertise for the 2020 fiscal year". Motion died for a lack of a second.
