5) Old Business

A) Update on proposed study and distribution of surplus funds – Copies of the draft of the proposed study were handed out. Matt S. reported that the study would begin the first of the year. The current draft does not include Argyle and Buffalo Gap Fire Departments and they will need to be added. At the October 23, 2019 Custer County Commission meeting a motion was made to allocate \$100,000 from the \$500,000 that was assigned to the Fire Advisory Board to be used to pay for the proposed study. Matt S. asked each department to submit comments on the scope of the study to him by December 1st. Paul J. made a motion to allocate the \$200,000 from the \$500,000 surplus funds to be used for current needs for each fire department and to follow the recommendation of the surplus funds committee. The funds to be distributed as follows:
