The surplus funds committee met at the Custer State Park Wildland Office to discuss the process for distributing the surplus funds of \$500,000 that was given to the Fire Advisory Board from Custer County. Jim S. called the meeting to order at 6:30 p.m.

Jim S. reviewed the minutes of the surplus committee meeting on June 19, 2019. Clarification was made on the reference to creating an emergency services district for the North Eastern part of the county was for ambulance services.

Discussion was held on how to get the funds distributed out to all the fire departments in the next year. The Fairburn VFD believes the study should be foregone at this late of a date and the funds be directly disbursed to departments by guidelines set forth by the County Fire Advisory Board. The idea of giving a base amount to each department and dividing the remaining amount on a percentage of total county valuation for each fire response area. Several ideas were expressed as to how to divide the funds. Jim S. expressed a need to cover all the fire departments in the county, including Edgemont and Hot Springs.
