#### F. Library

1. Doris Ann Mertz, Custer County Library Director, presented to the commission on the services the library provides. The library is a community space and utilized by patrons for many different uses. The library provides a \$6.20 return on every county dollar spent on the library. Mertz is looking at expanding the northwest corner of library and is looking at an extension of 27' x 62' on the current building. Mertz asked that the commission considering funding \$150,000 of the proposed project and the library foundation would cover the remaining cost. The commission thanked Mertz for her work at the library and expressed their appreciation for all the work she does for the library.

#### G. Safety Officer

1. The commission reviewed the proposed safety manual and asked that the manual include the names of those employees that would be serving on the safety committee and discussed the drug policy which will mirror the policy that is placed in the employee handbook.

Rex Harris, Planning Director informed the commission that the South Dakota Department of Transportation had notified him that the two mobile homes located outside of the RPZ Zone, and were part of the land purchased by the county, would not be included in the relocation plan. An amendment is being drawn up and will be sent to the county. The recommendation from the commission was to continue this discussion in Executive Session.

#### K. Veteran Service

#### L. Auditor

1. Motion by Sorenson and seconded by Lintz to approve additional training for the Auditor and Treasurer Office from Tyler Technologies and to approve payment of up to \$3,000 with the payment to come out of account #101-4-112-429.00, Commission Contingency. Motion carried, unanimous.

### M. Commission

1. Travis Hartshorn appeared before the board to discuss a non maintained road located in Sections 25, 26, 35 & 36, T6S, R8E, B.H.M, Custer County, South Dakota. Gary Woodford, Highway Superintendent stated he could not find where this road was ever placed on the county road system. Hartshorn stated the road is identified as a county road on the plat maps he presented. It was recommended that Woodford meet with Hartshorn and look at the road in question. Motion was made by Sorenson and seconded by Hartman to table this discussion until a work session can be completed by the commission to discuss the different types of roads and maintenance. Motion carried, unanimous.

- 3. Meeting Reports Lintz was unable to attend the Fair Board meeting on September 11<sup>th</sup> but did distribute a 5 year plan to the commission for the fair board.
