A) Sheriff Office Grant Assistance – Matt S. stated the Sheriff's Office has an employee that has experience in writing grants and has offered to allow her to help the fire departments write grants if needed. Bill B. noted that Mike C. has a lot of experience with grant writing and confirmed with Mike

that he would be willing to help with any grant writing. Mike C. stated the HLSA grants are now available to Fire Departments and the departments can apply January 1, 2019 through February 17, 2019.

- B) Supplemental Funding The Custer County Commission has assigned \$500,000 from excess funds to the Fire Advisory Board. Discussion was held on how to proceed with determining the best way to allocate these funds. Motion was made by Joel B. and seconded by Klinton R. to have all departments submit a three to five year plan by the next Fire Advisory Board meeting in January, 2019. Motion carried.
- C) Reimbursement for liability insurance Terri C. stated there are funds available to reimburse departments for their truck liability insurance. Departments will need to submit a copy of their liability insurance bill along with proof of payment to Terri by December 20, 2018, in order to receive the reimbursement this year.
