Custer County Commission Meeting (Wednesday, February 24, 2021)

A. Commission Meeting was called to order at 8:00 AM followed by the Pledge of Allegiance.

B. Commission Appointment & Oath of Office

This creates a vacancy on the board and needs to be filled according to SDCL 3-4-4. With the vacancy, Auditor Cornelison was instructed to temporarily fill the vacant seat on the board to create an odd number of voting members.
