E. Custer Elementary School

1. Custer Elementary Principal, Barb Paulson, presented to the commission regarding the establishment of an early learning group in Custer. The group will be putting a community survey together and will be sending to members of the community as well as the Custer County Commissioners and Custer County Department Heads.

F. Highway

- 1. Highway Superintendent, Jesse Doyle, gave an update on the Custer State Park pavement project on Wildlife Loop starting in August 2021. LH Road and Lame Johnny Road will be used as hauling roads as well as Beaver Creek Road will be used intermittently. Doyle noted there will be an increase in traffic on those roads and is working with Simon Contractors on a haul route agreement.
- 2. Doyle recently purchased a new traffic counter and gave the commission some statistics that have been collected by the counter thus far. Traffic count is necessary to determine where to apply magnesium chloride.
- 3. Doyle reported that an accident had occurred on Old Sawmill Road recently and there was damage to the guardrail on the bridge. A claim has been submitted and the county should receive payment from the insurance company of the driver of the vehicle that was responsible for the damage.

G. Director of Equalization

 - Recommended night firing be incorporated into your weapons qualifications program. Sheriff Mechaley reported this will be done in July 2021.
 - Recommended mutual aid agreements to be reviewed annually. Emergency Management Director Steve Esser will complete this by August 2021.
- 3. Motion by Hartman and seconded by Hindle to approve and authorize the chairman to sign the State of South Dakota Department of Health Division of Family and Community Health Sub-Recipient Agreement between Custer County and the South Dakota Department of Health Division of Family and Community Health Office of Child and Family Services for the period of June 1, 2021 through May 31, 2022; vote taken, all aye; motion carried.

I. 1881 Courthouse Museum

1. Rick Wheeler, Museum Board member, reported on funds needed to finish roof repairs on the Carriage House located on the museum property. The county has actual cash value coverage and the depreciation is not recoverable. Motion by Bies and seconded by Linde to approve the payment of \$17,386.31 to Home Masters with \$1,005.16 funded with the remaining insurance money received and for the remainder of \$16,381.16 to be taken out of the building fund account #250-4-161-432.70; vote taken, all aye; motion carried.

J. Custer County Senior Citizen's Center

 Custer Senior Citizen's Center Director Roxanne Horkey appeared before the board to request that Custer County proclaim Friday, August 27, 2021 as Custer Senior Citizen Center Day. Motion by Hartman and seconded by Hindle to approve an Executive Proclamation to designate Friday, August 27, 2021 as Custer Senior Citizen Center Day; vote taken, all aye; motion carried.

K. Custer County Search & Rescue

1. The commission acknowledged an updated roster for the Custer County Search & Rescue.

L. US Forest Service

1. Deputy Forest Service Superintendent, Jerry Krueger and Natural Resource Staff Officer, John Worth, appeared before the board seeking support on a proposed project to salvage trees affected by a tornado and wind event that occurred east and south of the City of Custer, South Dakota. Two areas have been identified with a large amount of tree damage. The large number of damaged trees sets the stage for an insect infestation to occur and effect the remaining stands and adjacent stands of trees. This project proposes to salvage harvest the down, broken and leaning trees from these areas and therefore, reduce the likelihood of an insect infestation and reduce the fuel loading in the higher concentrated areas. Motion by Hindle and seconded by Hartman to support the US Forest Service project; vote taken, all aye; motion carried.

M. Volunteer Fire Department

- 1. The commission acknowledged the updated Volunteer Fire Department Roster from Fairburn Volunteer Fire Department.
- **N. Public Comment** LeaAnne McWhorter reported on the taxation committee that had met Thursday, June 3rd; New Custer County resident Mark Sullivan inquired on who to contact regarding a proposed increase in his property taxes.
