## F. Emergency Management

- 1. Emergency Management Director Steve Esser reported on an estimate he received from GenPro Solutions for the modification of the generator mount and replacement insulation separator panel at Cicero Peak for \$2,113.51. Esser stated that funds were available through the Emergency Management 2021 Budget to cover this cost.
- 2. A Pre-Rally meeting was held at the Custer County Search & Rescue building on July 22<sup>nd</sup>. Estimates for rally attendance this year are high, including a potential for up to 1 million people.

# AMENDMENT NUMBER 1 TO THE CUSTER COUNTY AIRPORT MANAGEMENT CONTRACT

This Amendment Number 1 ("Amendment #1") to the Custer County Airport Management Contract, dated February 9, 2019, (the "Airport Contract") is approved by the Custer County Commission on this 28th day of July, 2021.

The Airport Contract shall be amended as follows:

Section 1, subsection H: Add the following sentence:

For the year starting 2022, the County shall pay the Manager \$3,850.00 per month (\$46,200.00 annually).

#### H. Request from Fall River County

1. Fall River County has requested Custer County to contribute to the Hot Springs Elderly Meals Program as they are delivering meals to Buffalo Gap residents. Consensus of the commission was to include this request in the next 2022 budget discussion.

# I. Custer County Volunteer Fire Department

1. Motion by Bies and seconded by Hindle to include Buffalo Gap Fire Department in the disbursement of the remaining assigned funds that was approved at the June 23, 2021 Custer County Commission Meeting and to issue a check for \$28,570 to the Buffalo Gap Fire Department with the funds to come out of the \$100,000 assigned for the fire study; vote taken, all aye; motion carried.

## J. Liquor Licenses – SDCL 35-4-11.1

- 1. Auditor Terri Cornelison presented information on Senate Bill 152, which amended SDCL 35-4-11.1 regarding the number of on-sale and off-sale liquor licenses that a county may issue each year. The county has until September 2<sup>nd</sup> to determine the number of on-sale and off-sale liquor licenses that it will approve for the next year as well as the fees charged for the various classes of licenses. More research needs to be done and this item will be placed on a future commission agenda.
- K. Public Comment Chet Ellsworth presented to the commission regarding the American Rescue Act committee that was formed at the July 14, 2021 Commission Meeting and has submitted a formal request to be placed on the agenda for the August 11, 2021 Commission Meeting. LeaAnne McWhorter gave an update on the Committee/Study Group to study tax issues in Custer County. They will meet at the Custer County Courthouse on Thursday, July 29, 2021 at 3p.m. in the Commission Room.

## L. 8:30 a.m. Public Hearing

1. A public hearing was held for a New Cell Tower Application from Earl & Stacey Sallee with a tower to be located on N2N2 of Section 11, T4S, R1E, B.H.M., Custer County, South Dakota. There was no one in attendance to either oppose or support the petition. Motion by Hartman and seconded by Hindle to approve the Cell Tower Application; vote taken, all aye; motion carried.

#### M. Custer County Volunteer Fire Department

1. Buffalo Gap Fire Chief, Randy Schroth, gave an update on the Buffalo Gap Fire Department. Frank Schroth has stepped down as Fire Chief and Randy Schroth has taken that position. Needs for the fire department include PPE equipment and training for new members. The department has several new members on the Volunteer Fire Department Roster.
