CUSTER COUNTY ORDINANCE NO. 22

AN ORDINANCE ESTABLISHING THE REQUIREMENTS, FEES, AND REGULATIONS FOR ISSUANCE OF ALCOHOLIC BEVERAGE LICENSES WITHIN CUSTER COUNTY

BE IT ORDAINED BY CUSTER COUNTY, SOUTH DAKOTA:

WHEREAS, the Custer County Board of County Commissioners (hereinafter the "Board") believes that alcoholic beverage licenses are a privilege and not a right, and Custer County (hereinafter the "County") reserves the right to refuse the approval, renewal, or transfer in the event an applicant refuses to comply with the requirements of this Ordinance or other applicable local, state, or federal laws; and

WHEREAS, Custer County issues multiple types of alcoholic beverage licenses, as those terms are defined by SDCL 35-1-1, and that it would be to the benefit to the County to specify by Ordinance the requirements, fees, and regulations for certain alcoholic beverage licenses; and

WHEREAS, the Commission previously enacted a similar ordinance, dated September 11, 1984; and

WHEREAS, the Commission desires to repeal the Custer County Ordinance dated September 11, 1984 and replace the provisions of that ordinance with this Ordinance No. 22; and

THEREFORE, BE IT ORDAINED BY CUSTER COUNTY, SOUTH DAKOTA, that the requirements, fees, and regulations for the issuance of certain alcoholic beverage licenses within the County be adopted as follows:

SECTION A. ON-SALE OR OFF-SALE LIQUOR LICENSE:

- 1. Availability and Notice of New License
 - a. By September 2nd of each year, the Custer County Auditor's Office shall determine the number of on-sale and off-sale liquor licenses available for the ensuing calendar year and report the same to the Board and the number of onsale and off-sale licenses and appropriate fees shall be set by resolution of the Board, and revised from time-to-time.
 - b. The number of on-sale and off-sale liquor licenses available shall be based upon the population of Custer County as set forth in SDCL 35-4-11.1.
 - c. No off-sale liquor licenses will be issued to any establishment less than three (3) miles from an incorporated municipality.

- d. If an additional on-sale or off-sale liquor license becomes available in Custer County, a notice will be published in the legal newspaper of the County for at least two (2) consecutive weeks, stating that the Board will be accepting applications for the new license, and setting a deadline or applications to be submitted.
- e. After the deadline has passed, all applications submitted to the Auditor's Office shall be submitted to the Board for consideration.

2. Application Process

- a. The application for an on-sale or off-sale liquor license, or the transfer of an existing license, intending to operate outside the corporate limits of a municipality within Custer County, shall be submitted to the Board for approval pursuant to SDCL 35-2-1.2.
- b. The application shall be accompanied by the required fee as set by state law or county resolution.
- c. An application for the transfer of an existing license to a new location or to another person shall comply with the requirements of SDCL 35-2-7.

3. Approval Process

- a. The Board shall fix the time and place for hearing upon all such applications that come before the Board.
- b. The Auditor's Office shall publish notice once in the legal newspaper of the County after a hearing date has been set. The notice shall be headed "Notice of Hearing Upon Application for Sale of Alcoholic Beverages." The notice shall state the time and place and where such applications will be considered by the Board, and shall state that any person interested in the approval or rejection of any such application may appear and be heard. The notice shall be publishes at least one (1) week before the hearing, pursuant to SDCL 35-2-5.
- c. At the time and place stated in the notice, the Board shall consider each application and any objection to the application before making its final decision on the application.
- d. The Board may approve or disapprove the application for an on-sale liquor or off-sale liquor license, or transfer of an existing license, depending on whether the Board considers the proposed location suitable, pursuant to SDCL 35-2-1.2.
- e. License application fees will not be refunded once the license is approved by the Board and issued by the State of South Dakota.

f. If the Board does not approve an application, it shall endorse on the application the reasons for the denial and return the application and fee to the applicant. No further application may be received from the applicant until after the expiration of one (1) year from the date of a denied application. However, if the application was denied based on the suitability of the location for the license, no further application may be received from the applicant until the expiration of three (3) months from the date of the denied application only if the application is for a different location, pursuant to SDCL 35-2-5.1.

4. Renewal Process

- a. Applicants for the renewal of an on-sale or off-sale liquor license shall follow the same application process as set forth above, by December 1st of each year for the ensuing year.
- b. An application for the reissuance of an on-sale or off-sale license may be approved by the Board without a hearing unless in the past year the licensee or one or more of the licensee's employees have been subjected to a criminal penalty for violation of the alcoholic beverage control law or the license has been suspended, pursuant to SDCL 35-2-1.2.
- c. The Board may not reissue any on-sale or off-sale liquor license issued pursuant to SDCL 35-4-2(4), (6), or (13) to the same licensee or the licensee's transferee if the license has not been actively used by the applicant during the two (2) years preceding the date of the current application, pursuant to SDCL 35-2-5.3.
- d. The term, actively used, as defined in SDCL 35-2-5.3, means that the licensed premise was open to the public during regular business hours for the sale and consumption of distilled spirits for at least sixty (60) days during the two (2) preceding years. However, the licensed premise is only required to be open five (5) days per year if it is open to the public during a special event that has at least twenty-five thousand visitors.
- e. No license granted under this ordinance may be reissued until all taxes incurred by the licensee as a result of the operation of the licensed premises, including municipal and state sales and use taxes, unemployment insurance tax, or any other state tax, are paid or are not delinquent. No license under this ordinance may be reissued until all property taxes which are the liability of the licensee levied on the licensed premises are paid or are not delinquent.

5. Other Alcoholic Beverage Licenses

Applicants for any other alcoholic beverage licenses issued by the County shall follow the requirements as set forth above, unless otherwise specified by South Dakota Codified Law or the South Dakota Department of Revenue.

6. Provisions Pertaining to All Licenses

All alcoholic beverage licenses issued by Custer County shall be subject to the following provisions:

a. Special Event Licenses

- i. Applications for special events licenses shall only be received by civic, charitable, educational, fraternal, or veterans organizations or any licensee licensed pursuant to SDCL 35-4-2(4), (6), or (16).
- ii. No fee is required with the application for a special events license.
- iii. Any license issued pursuant to SDCL: 35-4-124 shall be issued for a period of time established within the sole discretion of the Board, not to exceed fifteen (15) consecutive days.
- iv. No person or organization may be issued a permit pursuant to SDCL 35-4-124 more than three (3) times in any one (1) calendar year.
- v. No public hearing is required for issuance of a license pursuant to this section if the person applying for the license holds an on-sale alcoholic beverage license or a retail malt beverage license in the municipality or county or hold an operating agreement for a municipal on-sale alcoholic beverage license and the license is to be used in a publicly –owned facility.
- vi. The licensee must comply with all applicable state laws concerning the consumption of alcoholic beverages as set forth in SDCL Chapter 35-4.
- vii. Special events licenses may be issued for different alcoholic beverage licenses as specified in SDCL 35-4-124.

b. Time for Selling or Serving

i. No on-sale or off-sale licensee, licensed under SDCL 35-4-2, may sell, serve, or allow to be consumed on the premises covered by the license, alcoholic beverages between the hours of two (2) AM and seven (7) AM or at any time on Christmas Day, pursuant to SDCL 35-4-2.1, except for holders of on-off sale malt beverage licenses and on-off sale wine licenses which shall be permitted to sell, serve and allow consumption on the premises covered by the license on Christmas Day.

- ii. The sale, service, and consumption of alcoholic beverages shall be permitted on Sundays and Memorial Day, except between the hours of two (2) AM and seven (7) AM, pursuant to SDCL 35-4-81.
- iii. A violation of this section is a Class 2 misdemeanor, punishable by up to thirty (30) days imprisonment in the jail or a five hundred dollar (\$500.00) fine or both.

7. Miscellaneous

This Ordinance shall replace any and all prior ordinances or resolutions adopted by the Custer County Board of County Commissioners regarding the regulations, requirements, or distribution of alcoholic beverage licenses within the County, specifically the Ordinance dated September 11, 1984.

The County, by resolution, may periodically establish the number of current on-sale and off-sale liquor licenses available for the calendar year as well as the application and renewal fees.

Any provision regarding the requirements, fees, regulation, or distribution of alcoholic beverage licenses not addressed within this Ordinance shall be followed pursuant to South Dakota Codified Law.

1. Motion by Hindle and seconded by Linde to Approve Resolution 2021-15 with the Initial Fee for Off-sale Alcoholic Beverage License to be set at \$1,500 and the Annual Renewal Fee for Off-sale Alcoholic Beverage License to be set at \$500; vote taken, all aye; motion carried.

Resolution 2021 – 15

A RESOLUTION ESTABLISHING THE NUMBER OF ON-SALE AND OFF-SALE ALCOHOLIC BEVERAGE LICENSES AND THE FEES TO BE CHARGED THEREFORE

WHEREAS, SDCL Chapter 35-4 grants to counties certain powers to determine the number of on-sale and off-sale alcoholic beverage licenses available outside the corporate limits of municipalities in such county as the fees to be charged for such licenses; and

WHEREAS, SDCL 35-4-11.1 sets out the formula for county boards of commissioners to determine the number of on-sale and off-sale licenses are available in such county; and

WHEREAS, SDCL 35-4-2 enumerates the fees of each class of alcoholic beverage licenses;

NOW THEREORE, BE IT RESOLVED by the Board of County Commissioners of Custer County that, pursuant to SDCL 35-4-11.1 and based on the current population calculation of individuals residing within Custer County but outside the incorporated municipalities, the maximum number of on-sale alcoholic beverage licenses, as classified by SDCL 35-4-2(6), is six (6), and the maximum number of off-sale alcoholic beverage licenses, as classified by SDCL 35-4-2(3), is five (5).

BE IT FURTHER RESOLVED by the Board of County Commissioners of Custer County that the following license fees are as follows:

- On-sale Alcoholic Beverage License, as classified by SDCL 35-4-2(6):
 - o Initial Fee: Shall be the same fee for a similar license in the nearest municipality to the license location, as established in SDCL 35-4-2(6)
 - o Annual Renewal Fee: \$500
- Off-sale Alcoholic Beverage License, as classified by SDCL 35-4-2(3):
 - o Initial Fee: \$1,500
 - o Annual Renewal Fee: \$500

This Resolution shall become effective on the twentieth day after its completed publication.
