
ADOPTION OF ANNUAL BUDGET FOR CUSTER County, South Dakota

Whereas, (7-21-5 thru 13), SDCL provides that the Board of County Commissioners shall each year prepare a Provisional Budget of all contemplated expenditures and revenues of the County and all its institutions and agencies for such fiscal year and, Whereas, the Board of County Commissioners did prepare a Provisional Budget and cause same to be published by law, and Whereas, due and legal notice has been given to the meeting of the Board of County Commissioners for the consideration of such Provisional Budget and all changes, elimination's and additions have been made thereto.

NOW THEREFORE BE IT RESOLVED, That such provisional budget as amended and all its purposes, schedules, appropriations, amounts, estimates and all matters therein set forth, SHALL BE APPROVED AND ADOPTED AS THE ANNUAL BUDGET OF THE APPROPRIATION AND EXPENDITURES FOR CUSTER County, South Dakota and all its institutions and agencies for calendar year beginning January 1, 2022 and ending December 31, 2022 and the same is hereby approved and adopted by the Board of County Commissioners of Custer County, South Dakota, this 22nd day of September, 2021. The Annual Budget so adopted is available for public inspection during normal business hours at the office of the county auditor Custer, County, South Dakota. The accompanying taxes are levied by Custer County for the year January 1, 2022 through December 31, 2022.

# E. Conflict of Interest Declarations: None

## F. Planning:

1. Planning Director, Terri Kester, presented the Commission with AT&T Cell Tower Modification; Margery Fish 26151 Hwy 79; PIN 2094. Kester stated that this was brought before the Planning Commission on December 7, 2021 and was found to be compliant with Ordinance 15. Kester recommended approval. Motion to approve by Hartman; seconded by Linde; vote taken, all aye; motion carried.

- 2. Kester presented Final Tract of Hunsaker Tract 1; Hunsaker Tract 2; and Hunsaker Tract 3 and private access easement, located in Section 4; T5S; R7E; BHM, Custer County, SD. Kester stated this had been brought before and approved by the Planning Commission on December 7, 2021. She recommended Commission approval. Motion to approve said Tracts made by Linde; seconded by Hindle; vote take, all aye; Motion carried.
- 3. 2022 Fee and Permit Rate Schedule was presented to the Commission. Kester stated the only change to the schedule this year is the addition Vacation of Plat fee @ \$250. Motion to approve fee schedule made by Hindle; seconded by Hartman; vote taken, all aye; motion carried.
- 4. Planning Director Kester reported Appointment of Planning Commission Members 2022-2025. The two Planning Commission Members appointed are:
  - a) Aaron Davis
  - b) Aaron Hemingway

Motion to approve the two appointments made by Hartman; seconded by Hindle; vote taken; Linde nay, remainder aye; motion carried.

The appointed Alternate Planning Commission Member is Ron Lauritsen. Motion to approve Alternate made by Linde; seconded by Hindle; vote taken, all aye; motion carried.

5. Director Kester presented a Certificate of Appreciation to Ron Anderson, outgoing Planning Commission member. Ron has served diligently on the Planning Commission for the past six years. Custer County Commissioners thanked Mr. Anderson for his dedication and hard work.

### G. Sheriff's Department:

1. Lt. Steve McMillin requested the Commission to authorize payment of the Zetron Communications System in full. It was decided to make payment in the 2021 budget. McMillin stated that after payment is made, he can apply for reimbursement for a portion of the expense.

### H. Equalization:

1. Leah Vissia, Director of Equalization updated the Commission that the Department of Equalization has two open full-time positions for Appraisers. She asked the Commission to provide clarification if she should advertise for these two positions, check on contractors available to conduct a mass appraisal of Custer County. A discussion followed, thereupon, Hartman made a motion to table this matter until Vissia could research and provide more information to the Commission. This motion was seconded by Hindle; vote taken, all aye; motion carried.

Additionally, the Commission acknowledged that Tara Haswell is now deemed a South Dakota Certified Appraiser.

## I. Library:

1. Library Director, Doris Mertz, updated the Commission on the 2022 Library Board Appointments as follows:

- a) Outgoing members, Patricia Hoffman and Seyward Rittberger have both ended their 3-year terms.
- b) Mertz welcomed new members Cheryl Dillon and Katie Wiederholt to the board. Motion to approve new board members made by Hindle; seconded by Linde; vote taken, all aye; motion carried.

## J. Airport:

1. Anderson apprised the Commission that the Forest Service asked for a letter that the County would offer to purchase the Airport Tract for the Custer County Airport. She stated that she draft a letter that referred to applicable provisions of the Custer County Airport Conveyance Law that was enacted on March 12, 2019. She recommended that a motion be made for the Commission to approve the letter and authorize the Chairman to sign it on behalf of the Commission. Motion by Hindle and seconded by Bies to approve the letter to be sent to the Forest Service and to authorize the Chairman to sign letter to purchase the Airport Tract for the Custer County Airport. Vote taken, all aye; motion carried.

#### K. Public Comment:

Joann Boggs, President of the Elk Mountain School Board, stated that, on behalf of the Elk Mountain School, they are supportive of the West County Well Project. Commissioner Hindle briefed the Commission regarding the meeting with Trent. The following members of the public provided public comments to the Commission:

- 1. Bruce, an engineer with DGR Engineering, regarding the west county well project, and DGR will have a presentation for the Commission at the January 5, 2022 meeting of a scope for a community-based well to provide water for the growing community. Todd Fish also stated that with his discussions with state Legislative Audit representatives that to scope a well to provide water to a school with nine students may not be supportable pursuant to the criteria of the ARPA Grand.
- 2. Todd Fish, VSO, reported that he has had discussions with the Southern Black Hills Water and the City of Hermosa to schedule a time on a future Commission Agenda to discuss a request for a portion of the County's ARPA Grant funds to go toward water projects in the Hermosa area.
- 3. LeaAnn McWhorter expressed her concerns on the announced closing of the Custer Senior Care Center by Monument Health. Peg Ryan, Custer City Council representative, and Doris Ann Mertz also provided background on this matter. All expressed a need to request Monument Health to host a public informational meeting.

# L. Commission

- 1. Mail call
- a) Dept. of Agriculture and Natural Resources Industrial Stormwater Annual fee request. The Commission asked Jesse Doyle, Highway Superintendent, to research this matter and report back to the Commission.

- b) The Commission acknowledged a thank you letter from Hospice of North Ottowa Community in memory of Tim Holland's mother
- 2. USFS Forest Plan Revision Cooperative Agency Status of Custer County—Dave Thom from the Custer County Conservation District provided the Commission with a request to formally request that Custer County to participate as a cooperating government agency in the Black Hills Land and Resource Plan revision process that is getting underway. Anderson recommended that the Commission approve the letter and authorize the Chairman to sign. Thereupon, motion by Linde and seconded by Hartman; vote taken, all aye; motion carried.
- 3. Enhanced Concealed Carry class for Custer County employees. Commissioner Hindle reported that approximately 40 employees are interested in this class and stated the total cost to the County would be \$6,130 net. A discussion followed. Thereupon, motion by Bies and seconded by Linde to authorize the County to pay the costs for interested employees to attend a concealed carry class that would be paid from the HR Training Budget. Vote taken, all aye. Motion carried.
- 4. The 2022 Custer County Calendar was presented for review and approval. Motion by Bies and Seconded by Linde to approve the 2022 Custer County Calendar; vote taken, all aye; motion carried.
- 5. Meeting schedule. Highway Superintendent Jesse Doyle invited the Commission to attend the Highway Department Employee Appreciation Lunch to be held on Thursday, December 30, 2021 at 11 AM. The Commission directed the Auditor's Office to post the event.
- 6. There were no meeting reports.
