

Custer County Conservation District Meeting Minutes – June 9, 2022

The June 9, 2022 meeting of the Custer County Conservation District was called to order in the Pine Room, Custer County Annex, at 9:02 AM by Dave Thom.

In attendance were Dave Thom, Oonagh Wood, Paul Nettinga, Tamarah Caster, Stuart Adrian, Justin Boerboom, Joel Milos, and Mike Baldwin.

All motions were approved unanimously unless otherwise noted. For the purpose of continuity, these minutes are not necessarily in chronological order.

A request was made to add Riparian Workshop, Forest Plan Revision, and County Fair to the agenda under Old Business. The meeting minutes from May 12, 2022 and revised agenda were approved after a motion by Oonagh and a second by Tamarah, motion carried.

Partnership/Guest Reports:

- NRCS Representatives: Justin Boerboom and Joel Milos Report attached
 - Additional notes:
 - Joel Milos is the new District Conservationist in the Rapid City office.
 - There were approximately 10-12 applications for the Rangeland and Riparian Health CIS. Ranking deadline is July 1 and NRCS used the original CIS proposal to develop the ranking criteria.
- NWTF Forester:
 - Faryn Klebe was unable to attend but shared an update with Mike which he shared with the Board.
 - Faryn is working on the cultural resource surveys for the CIS contracts and the planned riparian workshop has been scheduled for October 13th & 14th at the Game Fish & Parks Outdoor Campus in Rapid. It will be primarily focused towards landowners. One day will be for restoration in forested areas and the other in grassland areas. We are contemplating moving the dates because the SAF conference coincides with those dates. This will be discussed at our next meeting. Also, Faryn signed up a new tree farmer that lives in Custer County.

Financial Report:

- Motion by Oonagh, second by Tamarah to approve financial report, motion carried.
 Oonagh asked about scholarship payments to the recipients. Mike is still waiting on enrollment confirmation from the students. He will reach out to them as a reminder.

Correspondence:

- SD Erosion Training Justin provided background information on soil erosion complaints and responsibilities of the Board. Board is encouraged to attend training in Rapid City next Tuesday, June 14.
- USDA seeking proposals for Joint Chiefs' Landscape Restoration Partnership Dave suggested a CCCD Board member work with NRCS and USFS to develop a proposal to treat lands in the county. Joel and Justin will work on contacting USFS.
- SDGFP Private Lands Habitat Biologist Tom Miklos is a new private lands biologist and will cover a portion of Custer County; however, Ben Pucket will still cover the majority of the county.

Old Business:

- Supervisor elections:
 - Public notice of election to be published for two weeks in the Custer Chronicle paper. Tamarah is working on her petition.
- Custer County Fair:
 - Board reviewed plan for booth at the County Fair this summer (August 11-14).
 The booth would not have to be attended all days. Paul will no longer be able to help staff the booth. Oonagh said that she could help Friday afternoon. Joel offered to work on Friday and Dave offered to help on Saturday.
 - NRCS can help with booth setup on Thursday and may be able to bring the mini rainfall simulator. They will also have pamphlets to share.
 - Booth will have a focused interest (e.g., soil health, CIS projects) including new
 material, partnerships with other agencies, county map with CIS and other project
 areas. Also, will have a drawing.
 - O Motion by Oonagh, second by Paul to purchase a \$200 gift certificate from Dakota Greens as a prize drawing, motion carried.
- National Wild Turkey Federation (NWTF) Riparian Workshop:
 - O Dave and Mike participated in a virtual meeting with NWTF and others to discuss a riparian workshop for landowners. The workshop is scheduled for October 13 and 14 in Rapid City at the GF&P Outdoor Campus West. The workshop will be a mix of agency talks and field trips. A follow-up planning meeting is scheduled for June 21.
- BHNF Forest Plan Revision:
 - Mike discussed recent meetings he attended in reference to the Forest Plan Revision. He is also trying to review the draft Assessments that USFS released to cooperating agencies. Public release of the draft Assessments is expected soon.

New Business:

- CIS Proposal for irrigation improvement project:
 - O The Board discussed how much money to request for the project. Justin's opinion was to request between \$1 and \$1.5 million due to the costs associated with center pivots, pipelines, etc. A motion was made by Paul, seconded by Tamarah to request \$1.5 million in the proposal, motion carried.

Other Business:

 - A Google Analytics page was created by Mike and is now tracking site use of the District's webpage.
 - O Newsletter:
 - Electronic copies of the spring/summer newsletter were sent out on May 24. Mike is still waiting on the hard copies to be printed. They will be mailed as soon as possible.

 - Mike provided a review of upcoming meetings that he will be attending.
