## E. Emergency Management:

- 1. Motion by Lampert, seconded by Hartman to authorize the chairman to sign the SLA Agreement. Motion carried, unanimous.
- 2. Mike Carter expressed gratitude for the number of groups and volunteers that help out during the rally. He wanted to specifically recognize Custer County Search & Rescue and the Argyle Volunteer Fire Department and prepared letters to be sent to those organizations. Motion by Hartman, seconded by Sorenson to approve the chairman's co-signature on those letters. The Commissioners verbally expressed their appreciation and noted the importance of volunteers in Custer County. Motion carried, unanimous.

3. Motion by Lampert, seconded by Hartman to go into Executive Session for a health issue notification. Motion carried, unanimous. Executive session began at 8:06 a.m. and ended at 8:16 a.m. with no action taken. SDCL 1-25-2(3).

## F. Highway Department

- 1. Motion by Hartman, seconded by Sorenson to approve the chairman signing the Brosz Engineering work order to complete the sign inventory.
- 2. The Highway Department is re-graveling the North and South entrances to Buffalo Gap. Woodford asked the commission if they wanted the Highway Department to apply mag chloride for the approximately 2 miles for about \$10,000. It was decided that they would do that during the annual schedule.
- 3. Woodford asked the commission to take out of surplus the 1997 blade with 13,000 hours. He'd like to use it for a trade-in with RDO. Wade Iszler with RDO presented two options. RDO offered \$51,000 for a trade-in which was much higher than anyone else offered. Woodford would like the commission to think about purchasing either a 2014 model with 4-years remaining on the warranty or the 2018 model with the full warranty. He would like to purchase it next year; perhaps January and be able to utilize money from his 2018 budget.
- 4. Mr. Lester from the Beaver Creek Road area had called about replacing the cattle guard on Beaver Creek Road. Gary Woodford thought that Leonard Wood thought years ago that it was no longer necessary. It was discussed that the fence was not adequate. The Forest Service feels it's a landowner problem.
- 5. Motion by Lampert, seconded by Hartman to move forward on the Hazelrodt trail restoration and fix the issue created with the construction of the road and bridge including it in the grant with SDDOT with the county paying 20 percent of the cost. Motion carried, unanimous.

- 3. Motion by Hartman, seconded by Lampert to authorize the hire of Kim Kerkvliet for the Administrative Assistant Position in the Planning Department at \$12.50 per hour starting Sept. 11, 2017.
