Minutes of the Custer County Special Commission Meeting, Wednesday, September 17, 2025.

2026 Budget Hearing

Members present:

Commissioners Mark Hartman, Mike Linde, Michael Busskohl, Craig Hindle and Dawn McLaughlin, Finance Officer.

A. Commission Meeting was called to order at 1:00 PM, followed by the Pledge of Allegiance.

B. Adopting of the agenda

1. Motion to approve Agenda made by Busskohl; seconded by Hindle; vote taken, all aye; motion carried.

C. 2026 Budget Hearing

1. Finance Officer, Dawn McLaughlin, presented the preliminary draft of the 2026 Budget, which totals \$13,289,102.14, which is a 1% (\$176,708.14) increase over the 2025 Budget. Based upon Commission recommendations, the Final Budget is \$13,037,867.00, which is a difference of \$251,235.14. Each department's request includes a 3% to 8% wage increase per employee based upon wage study completed by Human Resources. Aspire Empowered for Life is requesting \$720.00; RISE is a new request for \$5,000.00 in 2026; State's Attorney has requested to combine 441-444-445 accounts to the 441 account, eliminating the 444-445 accounts. Prisoner Care increased by \$200,000.00 per the Pennington County agreement.
