- 1. Lea Anne McWhorter stated that there was a property tax task force meeting (copy of agenda can be found on LRC page). Plans to decouple school student funding from property tax were discussed. A local tax group is concentrating on TIFs. Also discussed at the tax force meeting was additional sales tax as alternative funding; receipt tax; and options from state parks. October 22nd will be the last tax task force meeting—a decision will need to be made whether to move a bill forward.
- 2. Mark Hartman asked Mike Bielmaier about possible East Ambulance District formation and after talking with Hermosa Connects, this may have to be re-evaluated as progress is at a standstill. Hermosa Connects was originally planning on writing a resolution but feels they have acted hastily in the matter. Bielmaier said that he has been in contact with Rapid City Ambulance, and they will continue to service east Custer County.
